

**Hunter's Green WGA  
General Membership Meeting Minutes  
Saturday, April 30, 2016**

The WGA General Membership Meeting was held after the "End of the Season" tournament luncheon on Saturday, April 30 2016 and was called to order by WGA President, Nancy Sinkler at 1:20p.

Nancy Sinkler welcomed everyone and thanked Janet Kolb-Patton for chairing the tournament and Linda Evins and Aloise Keegan for their assistance. Returning members: Ann Carlson and Eileen Johnson along with new WGA members: Pat Baugh and Rhonda Lyons were welcomed.

Kathie Meyer made a motion to dispense with the reading of the minutes of the previous HGWGA General Membership Meeting held at the Season Opener in the Fall of 2015, the motion was seconded by Linda Evins, and the minutes were accepted as written.

Nancy Sinkler presented the treasurer's report in the absence of Beth McGucken. The checking account balance as of Friday, April 29 was \$1,983.14 after a deposit of \$1,613.72 from Hunters Green for Member/Member. \$1,266 was paid out today in prizes, ringers and tournament cash expenses.

After reimbursing members for their cash outlays for this and previous tournaments, the bank balance would be \$117.14.

The books were audited by Gigi Demick as of April 20, 2016 and found to be in order. We currently have 83 members. Dues were increased by the Board to \$50 for 2016-2017.

Nancy Sinkler recognized each board member and thanked them for their help and support this past year. She asked for volunteers to fill committee positions on the board.

Nancy went over the past season's schedule of events and thanked each one of the tournament chairs. Mary Dobson, Vice President, announced the following dates for upcoming golf events:
